Dear Shareholder,

Following an internal business review, please be advised that the Directors, in consultation with the Investment Manager, have formally taken the decision to close the Fund with effect on 27 November 2020 (the "**Termination Date**"). Due to changes in Indian financial regulation, the internal business review by the Investment Manager found that Indian fixed income exposure would be more efficiently provided within a broad-based emerging markets product rather than in a dedicated structure.


Until the Termination Date, you may voluntarily redeem your holding in the Fund for cash. Alternatively, you may, subject to the provisions of the Prospectus, also switch your current holding in the Fund for another sub-fund of the Company at no charge by faxing a signed instruction to BNY Mellon Fund Services (Ireland) Designated Activity Company (the "**Administrator**") at +353 1 8290841 to this effect. A pre-formatted instruction is appended to this letter for your convenience. Shareholders may access a wide variety of information on the range of available sub-funds, including the Prospectus, from [www.rubricsam.com](http://www.rubricsam.com).

Should you wish to switch into another sub-fund of the Company, then you should consult your financial advisor regarding a suitable alternative sub-fund. If you still hold Shares in the Fund on the Termination Date, the Directors will exercise their powers afforded under the Memorandum and Articles of Association of the Company ("**M&A**") and accordingly your shares will be compulsorily redeemed for cash with the net cash proceeds remitted to the account details on file for you. Accordingly, we hereby give you notice of the closure of the Fund pursuant to Article 12.01 of the M&A.

For any questions regarding this matter, Shareholders may consult their financial adviser, the Company's appointed representative in that country (where applicable), or the Administrator. Fees and expenses relating to the termination of the Fund will be borne by the Fund. Application will be made for the Fund to be de-listed from the Irish Stock Exchange on or after the Termination Date.
